## Recall Election

*Fair Work (Registered Organisations) Act 2009*

Nominations are called for:

- **Vice President (1)**

**Nominations**, which must be in writing and comply with the registered rules of the Organisation, may be made at any time from 11/03/2021.

Additional forms are available from the Returning Officer.

Any National Board Members may nominate an eligible person as a candidate for election.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than** 12:00pm Australian Eastern Daylight Time (AEDT) **on** 25/03/2021.

The ballot, if required, will open on 22/04/2021 and close at 10:00am Australian Eastern Standard Time (AEST) on 20/05/2021.

Each candidate shall have the right to appoint, before the close of the ballot, a scrutineer to represent them at the ballot and shall give notice of any such appointment to the Returning Officer.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
